

STUDENT DRESS CODE POLICY

PURPOSE

The purpose of the Student Dress Code is to outline Brookside P-9 College's requirements for student dress and appearance. It provides information about uniform purchase and support, dress code implementation and exemption processes.

This dress code has been developed by Brookside P-9 College's School Council in close consultation with our school community to ensure that it respects the rights of individual students whilst reflecting the values of the school.

The School Council has developed a dress code that we believe provides a range of choices for students and is cost effective for families.

The Student Dress Code aims to:

- foster a sense of community and belonging that encourages students to develop pride in their appearance
- support Brookside P-9 College's commitment to ensuring that our students feel equal and are dressed safely and appropriately for school activities
- reduce student competition on the basis of clothing
- enhance the profile and identity of the school and its students within the wider community.

SCOPE

Students are expected to comply with this Student Dress Code while traveling to and from school, during school hours and when attending school activities. If a student is unable to attend the College in full school uniform, communication which explains the reason and duration must be provided to the school.

UNIFORM AND APPEARANCE

The full list of Brookside P-9 College's compulsory school uniform items are available as Appendix A to this policy.

General appearance

While at school, travelling to or from school or participating in school activities, Brookside P-9 College students should comply with the following:

- Uniforms should be clean and in good repair
- Additional layers of clothing may be worn underneath the uniform for added warmth, provided these undergarments are completely hidden.

Jewellery and Nails

Students will be asked to remove jewellery if it is deemed to pose an OH&S risk. Students will be asked to cut long fingernails if they are deemed to pose an OH&S risk. No responsibility will be taken for injuries to self as a result of nail length or jewellery worn.

Hair and Sun safety

It is recommended that shoulder length or longer hair be tied back to help restrict the spread of nits and lice and for student safety. Hair will be required to be tied back if it is deemed to pose an OH&S risk.

School uniform hats must be worn by P-6 students when outside in Term 1 and Term 4. It is also recommended that students in Years 7-9 wear a hat when outside in Term 1 and Term 4.

Hats are not to be worn inside.

Students are permitted to wear sunglasses during outdoor activities.

IMPLEMENTATION

Brookside P-9 College will ensure that this Student Dress Code is communicated to all families and students through our website. We will assist students and families who may be experiencing difficulties complying with this policy.

Students wearing non-compliant uniform items may be asked to change into a compliant item of clothing provided by the school.

If a student is out of school uniform or otherwise breaches the Student Dress Code on a recurring basis, parents will be notified by the school. Measures taken by Brookside P-9 College to address concerns about non-compliance with the Student Dress Code will also be addressed in accordance with the Student Wellbeing and Engagement Policy.

EXEMPTIONS TO STUDENT DRESS CODE

Students and their parents or carers may apply in writing to the Principal for an exemption to this Student Dress Code if:

- an aspect of this code prevents the student from complying with a requirement of their religious, ethnic or cultural beliefs or background
- the student has a particular disability or health condition that requires a departure from the dress code, with supporting medical documentation

When the Principal receives a request for an exemption, they will:

- consider the grounds for the exemption request
- explain the process to the student and/or their parents/carers
- encourage the student and/or their parents/carers to support their application with evidence.

The Principal or delegate will try to negotiate a resolution that is acceptable to all parties. If an exemption is not allowed, then written reasons will be provided to the student and/or their parents or carers.

APPENDIX A: BROOKSIDE P-9 COLLEGE UNIFORM ITEMS

PRIMARY

The following items may be worn in P-6 all year round:

- Windcheater/Jumper
 Navy blue windcheater with school logo
 Woollen jumper with school logo
- Sports Polo Shirt Navy blue with school logo
- Shirt Blue long-sleeved shirt with school logo (to be worn with tunic only)
- Pants Navy blue track pants (leggings not permitted)
- Shorts/Skort Navy blue shorts Navy blue skort
- Dress/Tunic Dress with college green piping Tunic with college plaid

• Headwear

Navy blue broad brim hat with school logo is compulsory for P-6 in Term 1 and Term 4 Navy blue beanie Navy blue, green or white head bands, hair ribbons, "scrunchies"

Elastic Bands used to tie up hair may be worn in any colour

• Socks

White, Navy or Grey socks

Tights

Navy blue or nude tights

• Footwear

Black leather-look school shoes or black runners are permitted, except on days during which a student is attending PE where any colour runners are acceptable

• School Jacket

Navy blue fleece lined jacket with school logo

• Winter Scarf Navy blue scarf

SECONDARY

The following items may be worn in Year 7-9 all year round:

Academic Uniform:

- Pullover
 Woollen pullover with school logo
- Shirt Blue long sleeved shirt with school logo Blue short sleeved shirt with school logo
- Pants/Shorts Dark grey trousers Dark grey shorts
- Dress/Skirt Dress with college green piping Skirt with college plaid
- Socks White, Navy or Grey socks
- Tights Navy blue or nude tights
- Footwear

Black leather-look school shoes only are permitted, except on days during which a student is attending PE where any colour runners are acceptable

- School Jacket Navy blue fleece lined jacket with school logo
- Headwear
 Navy blue, green or white head bands, hair ribbons, "scrunchies"
 Elastic Bands used to tie up hair may be worn in any colour
- Winter Scarf Navy blue scarf

Sports Uniform Year 7-9

Only to be worn on designated PE practical day, academic uniform must be worn on all other days of the week.

- Navy blue sports polo with school logo
- Navy blue shorts
- Navy blue track pants (leggings not permitted)
